#### Something Old...Something New

Last month I had the pleasure of talking to you about the visit we made to Brian Beni's amazing collection of pre-war SS and Jaguar cars. I have still not been able to get the wonders of that visit out of my mind. Certainly, now it is time to prepare an article for the September Purr, I am finding it more than difficult to find a suitable subject. This club is about Jaguar. Not old Jaguars. Not rallies. Not slaloms. It is Delaware Valley JAGUAR Club so the first thing I thought I would touch on is "who is looking to buy Jaguar".

The press activity from July has slowed down and I have only seen two comments. The first reported that Jacque Nasser, the ex CEO of Ford and now head of a financial company, is to visit both the Land Rover and Jaguar factories and put it to the Unions that his organization is the one to bet on for their future. The Indian company Tata is still interested. The next comment was made by Matt Skelton, Editor of the magazine Jaguar World. In the lead article of the August issue he maintains that Ford has not actually said they would sell the two companies. The thing that started the media frenzy, he says, is that Ford went into talks with the UK Government to discuss both companies' future. He maintains that Ford has not issued an official confirmation or denial and suggests that "is it possible that Jaguar and Land Rover won't be sold at all?" Therefore I will leave the subject like that.

So lets talk about a new Jaguar that nobody seems to know exists and an old one of which Jaguar only made one copy. Unlike BMW, Mercedes and many other manufacturers Jaguar have not marketed, until recently, what is called an "Estate Car" in the UK or it can be called a "Shooting Brake" and in the USA simply a "Wagon".

In July, I purchased the Jaguar Wagon as a 50<sup>th</sup> wedding anniversary present for my wife. Yes, I am all heart. I reckoned such a gift would stand me in good stead for the next 50. Unknown to , my brother PGT in the UK also purchased the same car in the same week. He is over the moon thinking it is superb.



Though popular in Europe and the UK it has not been heavily promoted here and in fact I have never seen one on the road since I introduced one at the club party in December two years ago. When it was first introduced by Jaguar the US management decided that they would not release it here. They reasoned there was no market. Have you seen the number of BMW, Mercedes and Subaru wagons the road?? They then reversed that decision and made it available two years ago but did no promotion. Smart marketing!

Since I (we) have had one it has been amazing and unbelievable how many people have come up to me and made comments:-"I didn't know Jaguar made a wagon."

"It is a wonderful looking car."

"It is beautiful."

"If I knew Jaguar made a wagon as beautiful as this I would have bought one."

It's a good job Jaguar kept quiet or I may not have been able to get one.

The car has a 3 liter engine and is 4 wheel drive. It also has the sport function and has excellent off the mark go. I am told the 4 wheel drive makes it a delight to drive in the winter... we will soon see. We have a 2005 XJ 8 and though the X Type has a very smooth ride it does not match the larger car as I would expect. The interior champagne leather and controls are pure Jaguar. There is ample room for rear passengers. The rear seats fold down either completely or in sections. The tailgate lifts very high leaving a nice wide opening and the rear window can be opened independently so very useful if carrying very long items. The under-trunk floor space is well designed and there is even a plug-in to keep your lap top charged. Our car is equipped with a security cover to hide the contents held in the rear.

This is a first rate vehicle and the first time Jaguar has ventured into the wagon market. I



just don't know why they have kept it under wraps, but this is not the first time they have held back from marketing a wagon.

Back in 1962, the company sent a standard MK2 from the line to Jones Brothers in London for conversion... Nine months later it emerged as a British Racing Green wagon in all its glory. Known as the County Model and registered 3672 VC, it was used by Jaguar for many hack duties and spares support to race & rally events. The car was well used and eventually sold in 1968 to well known race competitor Coombs.



The car then passed through more hands, acquired wire wheels, and came up for sale in 1977 for \$7500. It eventually wound up in the USA. In fact it was from here in Philadelphia that it was, in the 1990's, sent to Holland by the Roadster Group for a complete restoration. The only Mk2 Wagon therefore is still in circulation. The photos of the car shown here were taken in Philadelphia and were given me by past DVJC President Jack Sanf.

The MK 2 wagon is the greatest rarity and one which has visited Philadelphia . The X-Type wagon is the first manufactured Jaguar wagon and if Jaguar's marketing effort in the US continues, it will become just as rare as the one off MK 2.

#### AUCTION ACTION

A 1949 MK V saloon. A barn find in need of total restoration. Condition 4. Sold for \$7,150. Then came a 1959 XK 150 S roadster. Black/tan leather.. 42,368 miles. Excellent paint & chrome. Outstanding interior. Condition 2. This car was sold new in New Jersey where it has spent all its life. Condition 2. NOT sold at \$140,000 against low estimate of just \$10,000 more Yes \$140K. Magazine Jaguar World ran, in August, an article on the XK 150 range of sports cars. Their main point was that the XK150 was presently realizing its full potential and that "they would not be surprised to see the first 200,000 British pounds (\$400,000) XK 150s very soon. Oh how after owning it since 1972 I grieve that I sold mine two years ago. Enjoy the dog days of summer.
